This website is partially compliant with the requirements set out in Appendix A of the UNI CEI EN 301549 standard, due to the non-conformities listed below.

#### Non-Accessible Content

The content listed below is not accessible for the following reasons – non-compliance with Law No. 4 of January 9, 2004:

- C.9.1.1.1 Not all non-text content presented to users has a text alternative serving the same purpose.
- C.9.1.2.2 Some pre-recorded audio content lacks synchronized captions.
- C.9.1.2.3 For some pre-recorded multimedia, no alternative or audio description is provided.
- C.9.1.2.5 For some pre-recorded video content, no audio description is provided.
- C.9.1.3.1 In some cases, information, structure, or relationships conveyed through page presentation cannot be programmatically determined (or are not available through text).
- C.9.1.3.2 In some cases, where the sequence of content presentation affects meaning, this is conveyed only visually and not structurally.
- C.9.1.3.5 The purpose of some input fields requiring specific data is not correctly communicated to assistive technologies, or not correctly implemented.
- C.9.1.4.1 In some cases, color alone has been used to identify a purpose or distinguish information or function.
- C.9.1.4.3 The visual representation of text and images containing text does not always meet the minimum required contrast ratio, except for cases allowed by the regulation (e.g., logos).
- C.9.1.4.4 Some text (excluding captions and text in images) cannot be resized up to 200 percent without assistive technology and without loss of content or functionality.
- C.9.1.4.5 In some cases, text images were used instead of plain text and are neither customizable nor essential to the conveyed information.
- C.9.1.4.10 Content that does not require two-dimensional representation (such as data tables or maps) does not reflow when the viewport size changes.
- C.9.1.4.11 For some essential components, even in different states, the color contrast with adjacent elements does not exceed the 3:1 ratio.

- C.9.1.4.12 When modifying text spacing (line height, paragraph spacing, letter or word spacing), some information or content is lost.
- C.9.1.4.13 In some cases, when mouse hover or keyboard focus makes content
  appear or disappear, there is no mechanism to dismiss additional content without
  moving the pointer or focus, the pointer cannot be moved over the additional content
  without it disappearing, or the additional content does not remain visible until
  dismissed by the user, removed, or becomes invalid, except in certain allowed cases.
- C.9.2.1.1 Some functionality is not operable via keyboard (or similar input interface).
- C.9.2.4.1 No mechanism is provided to skip blocks of repeated content across sections.
- C.9.2.4.3 In some sequential navigation contexts where the navigation order affects meaning or functionality, some objects that can receive focus do not do so in a logical or operable order.
- C.9.2.4.4 The purpose of some links cannot be determined from the link text alone or from the link text together with adjacent content.
- C.9.2.4.6 Some headings and/or labels do not adequately describe content or functionality.
- C.9.2.4.7 The focus indicator is not visible on some interactive elements.
- C.9.2.5.3 For some user interface components with labels including text or text images, the accessible name does not contain the text that is visually presented.
- C.9.3.1.2 In some cases, language changes in the text are not programmatically identified.
- C.9.3.3.1 In some cases, when an input error is automatically detected, the element in error is not identified and/or the error is not described in text.
- C.9.3.3.2 In some cases, labels or instructions are not provided when user input is required.
- C.9.4.1.2 In some cases, user interface components (including form elements, links, and script-generated components), their name, role, states, properties, and values are incorrect, unset, or not communicated to the user and their assistive technologies when changed.
- C.9.4.1.3 In some cases, status messages are not presented to the user in a way that assistive technologies can interpret without moving focus.
